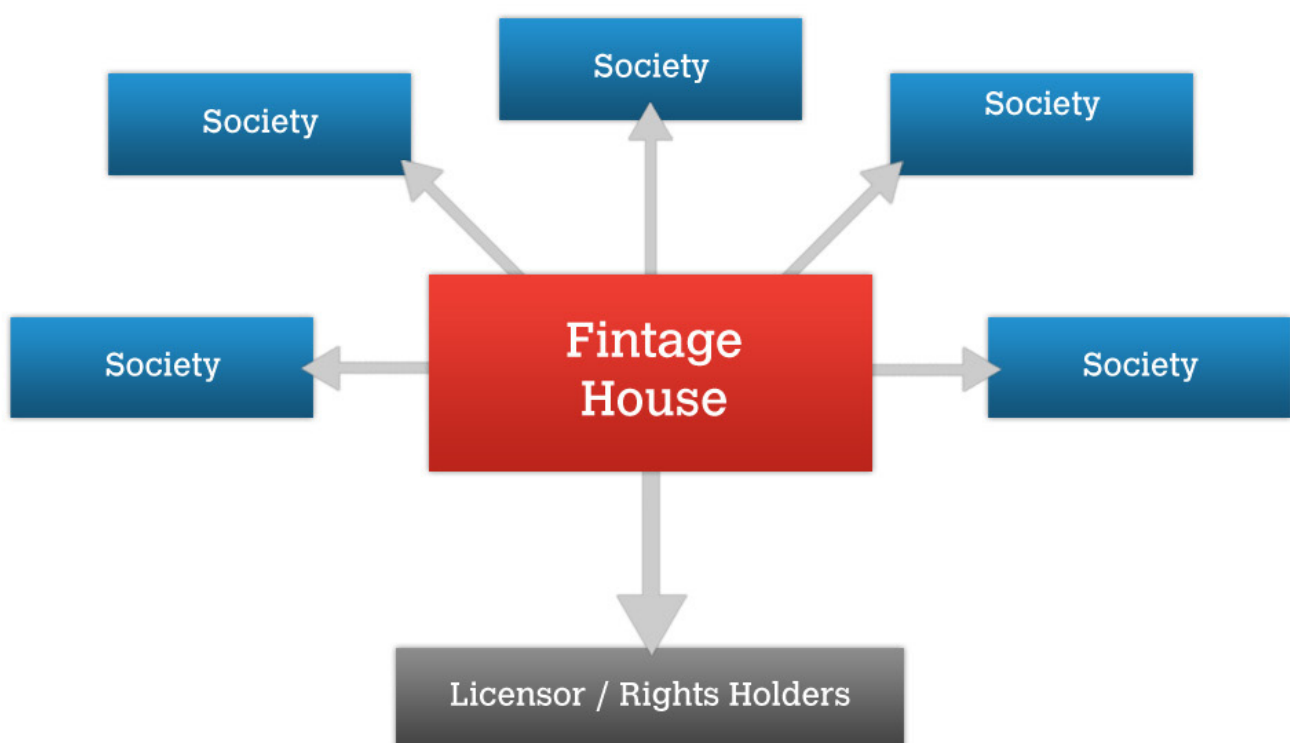
AV Producer Rights, also known as producer rights are non music related royalties which are allocated to rights owners whose film or TV program is broadcasted on TV on selected channels in Europe, North America, Japan and Australia. If one is not aware these royalties exist, they can be collected by those not entitles to them or worse lost forever.

Each country has its own society(ies) with their own rules and regulations to collect royalties but Fintage has direct memberships with all major collecting societies around the world meaning no middlemen, no double commissions, no time delay and more control.
